- SWG flat rate possibility. We will put a note in the 2nd quarter billing asking for concerns or comments.
- The City of Bellechester will buy into the Continental Billing system software for Sewer/Water/Garbage. Motion made by Rich Majerus and second by Doug Majerus. Motion carried.
- Crack Sealing of Streets will be done by the County when they have other sealing in the area.
- Ambulance regular meeting had assessments being issued at \$10 per person this year. A motion was made to approve the ambulance assessment bill by Rich Majerus and a second was made by Brian Ringeisen. Motion carried.
- The city is looking at putting a generator on the #3 Wellhouse. We may be able to apply for a grant for this item. We are waiting on several companies to give quotes and these quotes will then be sent to WSB for possible grant submission.
